- **PMEX Trading Fee Criteria:** The Securities and Exchange Commission of Pakistan (SECP) has approved the adoption of the criteria for the calculation of the PMEX trading fee @ 0.009% of the contract value for all futures contracts with a floor fee of Rs.30, except PMEX Milli Tola Gold Futures Contract, with effect from October 03, 2022. The contribution to Investor Protection Fund (IPF) will be @1%, and the SECP Transaction Fee will be 10% of the PMEX trading fee.
- **Capital Gains Taxes (CGT):** Capital Gain Taxes are 5% and 10% for filers and non-filers respectively.
- **Sindh Sales Tax (SST):** The Above mentioned KTrade Charges are subject to 13% SST.
- **Tariff for Capital Gains Tax (CGT) Related Services:** CGT tariff related charges are deducted from Rs.250 to Rs.10,000 per fiscal year by National Clearing Company of Pakistan Limited (NCCPL) on Annual Traded Value of Rs.100,000 to Rs.1 billion. (Circular No.: PMEX/MKT, BD&CSS/2017/31)
- **Margins** are subject to change as per PMEX directives.
- **IBFT Charges:** For IBFT (PKR 1 to PKR 100,000): PKR 25 + Tax & (PKR 100,001 and above): PKR 45 + Tax, Cash and third party deposits are strictly prohibited.
- **Intra-Day Contracts (ID):** Minimum margin requirement in ID will be half of the margin requirement in regular contracts with a flooring of 1%.
- **Auto-liquidation Threshold (ALT):** Exchange defined Auto-liquidation Threshold (ALT) for both, ID and regular contracts is 55%.
